In recent months, the Trump administration's inhumane policy of detaining and separating families seeking asylum in our country has [ripped thousands of immigrant children away from their parents and forced them into cages](#).

At 4:00 PM on Wednesday, August 15th at Penn's Landing in Philadelphia union members from the private sector, public sector, and building trades will hold a mass demonstration together with faith and community allies to express our outrage and call on the Trump administration to free the children and put an end to family detention.

Our nation cannot afford more Supreme Court justices who exercise such inhumane and cruel judgment when it comes to workers' rights.

Brett Kavanaugh's extreme views on workers' rights and on the power of government to counterbalance the power of big business make him one of the most anti-worker, anti-union Supreme Court nominees in generations.
